WHEREAS, the Annual Budget for South Brunswick Township FD No. 2 (the 'Fire District') for the fiscal year beginning January 1, 2023 and ending December 31, 2023 has been presented before the Board of Commissioners of the Fire District at its open public meeting of December 19, 2022; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$2,396,243.00 which includes an amount to be raised by taxation of \$1,081,430.00 and Total Appropriations of \$2,396,243.00; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 19, 2022 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2023 and ending December 31, 2023 is hereby approved; and

The total proposed budget of \$2,396,243 represents an increase of \$1,163,370 (+94.4%) compared to the 2022 adopted budget. The budget will be funded by a \$1,081,430 tax levy (up 2.4% and cap compliant), utilization of \$181,993 of unrestricted fund balance and \$1,100,000 of restricted fund balance, \$31,320 of grant monies and \$1,500 of other revenues. The primary cause of the proposed increase is the inclusion of a \$1,100,000 capital appropriation to support the lease/purchase of a new tower ladder that received voter approval in December 2021 and subsequently approved by the Local Finance Board in March 2022.

Restricted Fund Balance Utilized increased by \$1,100,000 (> +100%) - refer to questions 1 & 7 for additional information. Interest on Investments and Deposits increased by \$1,400 (+1,400.0%) due to rising interest rates. Total Operating Grant Revenue and Expenses increased by \$25,940 (+ 482.2%) due to the award of an American Rescue Plan - Firefighter Grant (ARP-FFG). Total Administration - Personnel expenses are up by \$25,324 (+11.1%) due to contractual increases and higher fringe benefit costs. Turnout Gear - 10% Match is up by \$3,000 (> +100%) due to the aforementioned grant award in question 1. Total Capital Appropriations increased by \$988,405 (+368.8%) due to a \$1,100,000 appropriation to support the lease/purchase of a new tower ladder as explained in questions 1 & 7 offset partially by a reduction of \$111,595 in Reserve for Future Capital Outlay. Total debt service of \$205,271 for 2023 is \$101,926 (+98.6%) higher than the current year budget due to a one year overlap of two existing leases with one being fully retired next year. Please refer to question 7 for additional information.

If Unrestricted Fund Balance is reduced by more than 10%, explain the projected impact on the following year's budget.

The proposed amount to be raised by taxation of \$1,081,430 is \$25,430 (+ 2.4%) higher than the 2022 adopted budget and is Property Tax Levy Cap compliant. The proposed tax rate of \$.043 per hundred is the same as budgeted in 2022. There is no anticipated significant impact on the following year's budget due to the use of \$181,993 of unreserved fund balance as there remains a projected balance after utilization of \$401,099. The restricted fund balance after utilization of \$1,100,000 in 2023 is projected at \$506,239 and is sufficient to meet the needs of the district for the next several years.

Capital Appropriations for 2023 are \$1,256,417 of which \$1,100,000 of existing capital fund balance is being utilized toward the purchase of a new Tower Ladder which received voter approval in December 2021 in combination with a lease/purchase of \$650,000. The other \$156,417 is being reserved for future capital outlay.
Total debt service of \$205,271 for 2023 is \$101,926 higher than the current year budget due to a one year overlap of two existing leases with one being fully retired next year. Debt service for 2024 will then be reduced by \$103,345 with the retirement of the one lease.
