Chief Spahr reported that he instructed all firefighters to begin scheduling their physicals with Dr. Weingarten's office with a target completion date of May 1st.

Chief Spahr reported that the Township is moving forward with plans to demolish the house on Friendship Road that we have used for training for quite a few years. As a result, the Fire Department changed the training schedule in order to use the building one last time.

The Fire Department has been asked to participate in the little league opening day ceremonies as well as a youth day event at the YMCA, both in April. There are several members interested in participating and they will try to send a truck to each event.

Chief Spahr reported that he received a fax from the National Fallen Firefighters Foundation, requesting an official resolution from the governing body recognizing the Fire Department as an official provider of emergency services. The document will be kept on file and be used to provide the Public Safety Officer's Benefit in the event of a line of duty death. Chief Spahr will give the Board a copy of the fax.

Energy Audit & HVAC System Repairs

Chairman Spahr reported that he and Coordinator Smith had a conference call with TLC, Tri-State Light & Energy, and Sterling HVAC on March 13th in order to determine the status of the energy audit. Chairman Spahr further reported that several weeks prior, he was informed that the replacement of the office furnace, programmable thermostats, and demand control ventilation at Station 20 were removed from the project as the replacement parts would not provide the increase in efficiency required by the program. All other work has been completed at both stations and Coordinator Smith will be submitting the final paperwork in order to receive reimbursement of the final 25% of the cost of the audit.

Coordinator Smith will be in contact with Sterling HVAC to complete the repairs to the office system, which are part of a separate contract that was approved last year. The representative from Sterling stated that this work will be completed by the end of the month.

EXECUTIVE SESSION MARCH 19, 2012 MINUTES

Chairman Spahr announced the session was being called to discuss the replacement of the District Secretary. Chris Smith has resigned, due to her workload at her full time employment. District Coordinator Scott Smith has performed that service in the secretary's absence, and has performed well.

Comm. Young's observations are that yes the coordinator has performed well in preparing the minutes and has not requested anything in return. We need to remember that the district is bound to a 2% increase in our budget. Comm. Young recommended we hold off on adding duties and compensation at this time. The district will be negotiating a new contract with Mr. Smith prior to the end of the year. That would be the appropriate time to negotiate those issues. It was agreed we would take up the change to the coordinators job description and compensation in the new contract.

Comm. Young then spoke to the issue of getting someone to begin the process of setting up a web site, to comply with legislation that has been enacted. We must be on line by February 2013.

All were in agreement we would look in house first to see if we had someone both capable and available to fill the need.

Fire District Coordinator's Report March 19, 2011

- The Fire Department has three new members. Tanim Awwal joined in February and has started Firefighter I. Henry Ngan and Vivian Robbin-Mason also joined and will be going to Firefighter I in the fall. There are several other residents who are in the application process as well. Member Tim Bogus, who joined back in October, is currently in Firefighter I. Junior Firefighter Jay Patel has resigned from the Department because of a lack of time due to school.
- Our computer tech switched the off-site server back-up service to MozyPro on 2-22-2012 and cancelled our previous service with Intuit Quickbooks. A credit card was required, and a total of \$186.45 was charged to the Fire Department's credit card for a one-year subscription to the service. Our computer tech has finished the installation of the new server and desktop computers. He still has some minor items to work on, which he will be completing during his regularly scheduled maintenance visits.
- Cummins Power Systems was on site on 2-28-2012 to perform the 6-month preventive maintenance inspection on the emergency generators at both stations. The unit at Station 21 was inspected and found to be in good condition with no problems. The unit at Station 20 was low on anti-freeze due to a loose clamp that allowed a slow leak. The clamp was tightened and the anti-freeze level topped off. The oil pressure switch for the block heater was stuck and they recommended replacing. They will be providing a quote to replace the switch. The radiator cap and air filter were replaced in house on 3-1-2012.
- TruGreen was at both stations on March 1st to perform the spring lawn treatment.
- I drafted a Fire Safety & Evacuation Plan for Station 20, which I forwarded to everyone. The plan is required for the building based on the multi-purpose room under the Uniform Fire Code. The plan details steps to take in the event of alarm activation and/or an actual emergency. I also created a site and floor plan which will be attached to the evacuation plan. I will be posting the document next to the calendar in the general office. I made an announcement at this month's Fire Department meeting to inform the membership of the plan.
- In preparation for applying for the Assistance to Firefighters Grant program through the Federal government, several of the line officers met with salesmen from Nat Alexander on 2-28-2012 to demo to the latest models of Scott Air Packs. We received a quote of \$5,329.50 per air pack, and \$1,302.40 per air cylinder. I have started reviewing our maintenance records for the last couple years to obtain the amount of information spent on repairs, as well as the grant application information for past years in order to be as ready as possible. According to the website, the grant application period should be starting sometime in the June/July/August timeframe. They offer grant seminars and usually have one in the area which I will try to attend.

- Air & Gas Technologies was on site on 3-6-2012 to replace the CO monitor in the Bauer breathing air compressor at Station 21.
- Roth Bros. was on site on 3-12-2012 to perform the annual roof inspection. They inspected the roof over the weight room where we had the leak in January. They were able to seal the area where the roof meets the wall and they feel that there shouldn't be any further problem in this spot. There were no other issues found with the roof during their inspection. We should be receiving a detailed inspection report shortly.
- We received the maintenance service contract from TASC for the Hurst rescue tools. The cost for the service is \$1,380.00. I recommend we renew the contract with TASC. The equipment is due for maintenance in April.
- I completed a total of 18 occupancy pre-plans in February, with a total of 45 preplans for the year so far.

Insurance:

- There are two invoices for VFIS on the voucher list this month. One is in the amount of \$1,843.29 for the quarterly installment of our group term life plan. The other is in the amount of \$178.00 for the increase of the Medical Expense Maximum Amount under the Accident & Sickness policy to \$50,000.00, which was approved last month.
- Ed Lidy was injured on 3-13-2012 after being accidentally struck in the eye by a piece of equipment during an informal training session at Station 20. He was taken to Princeton Hospital where he was diagnosed with an eye contusion, as well as an eyelid laceration, and received one stitch. A cat scan was performed as a precaution with no problem found. Ed visited Dr. Niemczyk's office on 3-14-2012 and was told there is no damage to his eye, only a bruise, and was given ointment. He has a follow-up appointment scheduled with the eye doctor for 3-19-2012 where he will have the stitch removed. The hospital and eye doctors signed the necessary forms, and I completed the other required paperwork and forwarded everything to VFIS.

In the Assembly referred to HOUSING and LOCAL GOVERNMENT. In the Senate referred to LAW and PUBLIC SAFETY

A1503 Requires Fire Districts, School Districts, County Governments, to share in the burden of property tax appeal refunds. Introduced 1-10-12 referred to Assembly Housing and Local Government Committee.

S2 A1171 Bill deals with Shared Services and Consolidations. Sponsor of this bill is Senate President Sweeny. The bill gives broad powers to the LURAC Commission., punishes those that do not implement Shared Services recommended by LURAC. Hearing 2-27-12 Numerous amendments from original bill. Passed out of committee 3to2

S-1174. Sponsor Senator Turner, Mercer County. This bill would move Fire District Elections to November. Would allow for a petition to Board of Fire Comm. By 15% of the number of voters in the last election to present a petition. We would then be required to hold a public hearing, within sixty days. We would then be required to hold a referendum. Would also permit the Municipal Government to move the elections by the simple passing of a Resolution.

The State legislators will from today 3-19-12 until at least May 24th be only working on budget hearings.

It is my understanding that Senator Donald Norcross still intends to submit legislation to move the elections to November and within that legislation deal with surplus monies.

WHEREAS, there exists a need for first aid services for the members of the Monmouth Junction Fire Department while engaged in fire fighting service to the residents of Fire District No. 2 South Brunswick Township, Middlesex County; and,

WHEREAS, funds are available or will be available for the purpose of obtaining such service; and,

WHEREAS, the Local Public Contract Law N.J.S.A. 40A11-1 et seq, require that a resolution authorizing the award of contracts for professional services without competitive bidding must be publicly advertised; and,

NOW THEREFORE be it RESOLVED on this 19th day of March, 2012 by the Commissioners of Fire District No.2 in the Township of South Brunswick, County of Middlesex, as follows.

- (1) The Monmouth Junction First Aid Squad is hereby appointed as the attending first aid squad for the Board to serve for a term of one year or until the organization meeting of the Board of Fire Commissioners following the annual election.
