Comm. Young nominated Comm. Smith for Vice-Chairman, seconded by Comm. Bellizio. Comm. Potts closed the nominations for Vice-Chairman, seconded by Comm. Bellizio.

Comm. Potts nominated Comm. Young for Treasurer, seconded by Comm. Smith. Comm. Bellizio closed the nominations for Treasurer, seconded by Comm. Smith.

Comm. Young nominated Comm. Potts for Secretary, seconded by Comm. Bellizio. Comm. Smith closed the nominations for Treasurer, seconded by Comm. Young.

#### 6. ITEMS TIMELY AND IMPORTANT

Chairman Spahr reported that he received a letter from Christine Smith notifying the Board of her resignation as recording secretary. A discussion will be held during executive session prior to the March 19<sup>th</sup> regular meeting to discuss the filling of the recording secretary position.

Commissioner Young reported that he received a copy of the contract from OK Enterprises for the computer/server maintenance, which expires in March. This topic will be discussed during executive session on March 19<sup>th</sup>.

Comm. Potts reported that he had spoken briefly with Joe Giorgio from VFIS regarding a recent case in Tinton Falls, New Jersey. In the case, the Fire Department was sued following an incident in which a resident was electrocuted and seriously injured. The ruling found the Fire Department 60% responsible for the injuries, resulting in a multi-million dollar verdict for the injured party. Comm. Potts feels that the District and Fire Chiefs should meet with the Police Department and representatives from the Township to discuss transfer of responsibility on emergency scenes.

Chairman Spahr reviewed the status of the energy audit and remaining funds for the program. Chairman Spahr reported that the installation of the replacement furnace was removed from the contract as a new model would not provide an adequate increase in efficiency over the current unit. It was decided to contact the energy company to pursue having the unit installed per the contract, as there have been issues with the existing furnace in the past.

Comm. Young reported that he closed out the 2011 financial records and sent the documents to the auditor.

#### 7. ADJUOURNMENT

A motion to adjourn was made by Comm. Young seconded by Comm. Smith and by a voice vote all voted in affirmative. Meeting adjourned at 8:20 p.m.
