SPECIAL MEETING SOUTH BRUNSWICK TOWNSHIP BOARD OF FIRE COMMISSIONERS – DISTRICT #2 December 10, 2012

1. CALL TO ORDER:

The meeting was called to order by Chairman Spahr at 7:30 pm followed by a salute to the flag.

2. NOTICE OF COMPLIANCE:

Chairman Spahr read the Public Laws Meeting Notice of the Public Laws of 1975 and the Special Meeting Notice.

3. ROLL CALL

4. ORDER OF BUSINESS

Final Presentation/Discussion on 2013 Budget

Comm. Young distributed copies of the proposed 2013 Budget to those present.

Comm. Young reported that he incorporated all of the changes that were discussed at the last meeting.

Comm. Young further reported that the ratable base for 2013 is projected at \$2.0 billion, which is down 1.8% from the actual 2012 ratable base. The amount to be raised by taxation remains the same as the last two years. The tax rate rises from .041 to .042 per hundred due to a lower base.

Comm. Young reported that there are no capital improvement outlays proposed for 2013. The reserve for future capital outlays will be \$50k, which is the same as 2012.

The final budget for 2013 is \$1,020,559.00. The total amount to be raised by taxation is \$828,865.00.

Resolution #12-20, Approval of 2013 Budget

Fire District No. 2 FISCAL YEAR: From January 1, 2013 to December 31, 2013

WHEREAS, the Annual Budget for the South Brunswick Fire District No. 2 for the fiscal year beginning January 1, 2013 and ending December 31, 2013 has been presented before the Board of Commissioners of the Fire District No. 2 at its open public meeting of December 10, 2012; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.) and,

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$1,020,559, which includes amount to be raised by taxation of \$828,865 and Total Appropriations of \$1,020,559; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District No. 2 has taken into account the assessed valuation of taxable property in the Fire District No. 2,

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District No. 2, at an open public meeting held on December 10, 2012 that the Annual Budget, including appended Supplemental Schedules, of the South Brunswick Fire District No. 2 for the fiscal year beginning January 1, 2013 and ending December 31, 2013 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the said Fire District No. 2 's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the South Brunswick Fire District No. 2 will consider the Annual Budget for adoption on January 22, 2013.
