The meeting was called to order by Chairman Spahr at 7:30 pm followed by a salute to the flag.

6. PROFESSIONAL REPORTS

Chief's Report

Chief Scott Smith reviewed the February 2013 Activity Report (see attached).

Chief Smith reported that the Fire Department will be attending a live burn at the Somerset County Fire Academy on Saturday March 23rd.

Chief Smith reported that instructors from the Live Fire Training Institute will be on site on Saturday April 6th to perform refresher training on the compressed air foam system on Engine 206, as well as an operational inspection on the pump. This is the same company that performed the initial training for the Department when the truck was delivered in 2010.

Chief Smith reported that Commissioner Smith and Chairman Spahr have been working to construct a bail-out training prop at Station 20 and thanked them for their efforts. It is anticipated that the Township-owned house on Friendship Road that the Fire Department has been using for this training will be demolished at some point in the future. Also in the works is a roof prop for training on ventilation.

Chief Smith requested permission to purchase four (4) Motorola Minitor V pagers with a three-year warranty at a cost of \$1,311.00 from Leavitt Communications. Included in this price is a trade-in of five older model Motorola pagers. This request will be discussed under Timely & Important.

District Coordinator's Report

Coordinator Smith reviewed the March 2013 Coordinator's Report (see attached).

Coordinator Smith reported that he purchased a Samsung Galaxy Note tablet for day-to-day use after speaking with the Commissioners and thanked them for their consideration for the purchase.

Coordinator Smith reported that there is a trouble alarm on the fire alarm panel at Station 21 due to a bad back-up battery. A replacement battery has been ordered and will be installed without the need for the alarm company to respond.

Coordinator Smith reported that there is an air line leak on the Bauer breathing air compressor and that he has contacted Air & Gas Technologies to send out a technician.

Coordinator Smith reported that he received a quote of \$1,600.00 from Accredited Lock Supply to replace the mechanical combination locks on two man doors at Station 20 with electronic locks. This request will be discussed under Timely & Important.

Insurance Chairman's Report

Coordinator Smith reviewed the February 2013 Insurance Report (see attached).

Treasurer's Report

Comm. Young reported that there have been two deposits since the last meeting. The first deposit was made on March 1st from South Brunswick Township in the amount of \$126.00 for a hazardous materials reimbursement. The second deposit was made on March 14th from South Brunswick Township in the amount of \$1,150.00 for dedicated penalty monies for 2012 from the Fire Safety Bureau.

Comm. Young reported that he forwarded the 2012 final financial data to the auditor electronically. Comm. Young has also gathered all of the monthly financial records for the last year and they are ready to be delivered to the auditor upon his request.

Comm. Young distributed the latest monthly financial reports to the Commissioner's mailboxes earlier this afternoon.

Legislative Report

Comm. Potts reported that the bill to move the fire district election to the general election was pulled from the hearing scheduled for last Monday and that he does not anticipate the bill will be heard within the next 3 months due to budget hearings.

Coordinator Smith reported that he spoke with the Regional Grant Specialist from FEMA regarding the use of surplus funds. In the event there are surplus funds after the purchase of the requested equipment, FEMA has increased the amount of money that can be spent to \$10,000.00 from the same category without the need to request approval.

Coordinator Smith further reported that he received an e-mail from FEMA stating that grants awarded under the 2012 Assistance to Firefighters Grant program will not be affected by the government sequester cuts.

Fire District Coordinator's Report March 18, 2013

- Attended meetings on February 28th, March 1st and March 15th to look at replacement computer programs for Fire Safety. It appears that Fire Safety will be going with a program by Spatial Data Logic. The salesman is working with the computer techs to determine how the Fire Departments will be able to access the information in the database (i.e. pre-plan information).
- Donald C. Rodner was on site on 3-4-2013 to look at the mezzanine HVAC unit after it was found that the unit was blowing cold air. It is believed that the economizer that was installed on the unit as part of the energy audit is causing the problem. Chairman Spahr has been in contact with Tri-State Energy and Sterling Heating & AC to address the problem.
- Roth Bros. was on site on 3-13-2013 to perform the annual preventive maintenance/inspection of the Station 20 roof, which was last performed in March 2012. Cost for the annual service is \$1,670.92. The technician made several repairs to seams and joints throughout the roof. We had noticed several leaks, including repeat leaks in the gym and general office, as well as a leak outside the side entrance by the gym. Chairman Spahr had opened the overhang outside to better diagnose the leak. We will keep an eye on the spot and look to have repaired once we are sure the leak was fixed.
- I have scheduled Car 200 (Explorer) to go to Agin's on March 28th to repair and seal the gold leaf lettering, and scheduled Car 210 (Expedition) for March 29th to seal the gold leaf.
- We had two burglar alarm activations at Station 20 on 3-9-2013, apparently caused by a malfunction. Fire Security Technologies was on site on 3-13 and determined the problem to be with the sensor for the center engine bay door. A replacement sensor has been ordered.
- I obtained a quote from Diversified Inspections to have the aerial and ground ladder testing performed. Cost for the Bronto is \$750.00, and cost for the ground ladders is \$494.00 (247' x \$2.00 per foot). Total cost is \$1,194.00. I recommend having the aerial and ground ladder testing performed by Diversified Inspections.
- I have contacted Absolute Fire Protection and Fire & Safety to provide quotes for the annual preventive maintenance/service on the three pumpers. Fire & Safety provided a quote of \$1,885.00 for 204 & 208, and \$2,180.00 for 206 (higher due to additional service on CAFS pump). I received a quote from Absolute in the amount of \$1,160.00. All prices are the same as 2012. As performed last year, I recommend using Fire & Safety for Engine 206 and Absolute for Engines 204 & 208. I am

targeting starting service in April with one truck each month through July (including Bronto by Fire & Safety at no charge).

- I have scheduled the firefighter physicals with Access Health at Station 20 for Thursday April 25th. I had originally planned on having two nights, however, we would have less than the minimum amount of people for each night.
- I completed a total of 12 pre-plans in February for a total of 22 for the year.

Insurance:

• I spoke with the insurance adjuster from VFIS on 3-12-2013 regarding the accident involving Engine 206 that occurred on 1-30-2013. He informed me that the owner of the other vehicle involved submitted the claim to his insurance company, and that he was responsible for his \$200.00 deductible. VFIS issued a check to this individual on 2-12-2013 in the amount of \$200.00 for reimbursement of the deductible and the claim was closed out that day.
