The total proposed budget of \$1,567,432 for 2026 is \$250,232 (+ 19%) higher than the 2025 adopted budget. The two main drivers of the increase in spending are due to higher capital appropriations of \$110,000 and increased spending for Operations Salaries and Benefits of \$61,781 due mostly to the planned hire of an additional firefighter in July of next year.

3. **Explain any variances over +/-10% for each line item.** Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item. **Be sure to include ALL items for F-2, F-3, and the detail sheets.**

Unrestricted Fund Balance Utilized was increased to offset the increased non-capital spending. Restricted Fund Balance Utilized increased to cover two capital projects being funded from existing capital reserve funds. Administration Salary and Wages increased to cover contracted increases. Operations & Maintenance Salaries & Wages/ Fringe Benefits are up primarily due to the aforementioned planned hire of an additional firefighter in July of next year. Total Capital Appropriations are up due to the previously mentioned two capital projects and an increase in the amount to be reserved for future capital expenditures. Group & General Insurance are budgeted higher due to current rate increases realized. Training increased for the planned attendance of the District Coordinator at the 2026 FDIC (Fire Department Instructors Conference). Utilities increased for higher anticipated rate hikes. Debt Service interest is down due to more principal being applied to the outstanding capital lease payment as per the Amortization Schedule. Total Debt Service is the same as last year with \$2,161 more being applied to principal and \$2,161 less going toward interest as shown on Page F-3.

The proposed budget reflects a 5.6% increase in the amount to be raised by taxation and is compliant with the property tax levy cap. The tax rate will increase slightly by \$.002 per \$100 resulting in a 4.3 % impact on the average homeowner.
